TERMS and CONDITIONS

(For purposes of abbreviation Pony Parties in Miniature will be referred to as PPIM, completion of the booking form and / or payment of the deposit and balance of payment is deemed to be acceptance of these terms and conditions)

1. **BOOKINGS** - If you wish to make a taster booking with PPIM, please contact us in the first instance by e-mail or telephone to check availability of your preferred date / time. miniparties@mail.com 07855 509734
Once a date and time have been agreed print a copy of our booking form and post or hand deliver to: Pony Parties in Miniature, Wood End Barn, Wood End Lane, Curborough, Lichfield, Staffs. WS13 8EW.
2. **PAYMENTS** – Payment should be made at time of booking can be made by... (1) credit or debit card over the phone, (2) PayPal using friends and family miniparties@mail.com (3) Bank Transfer SORT CODE: 53-70-15 ACCOUNT NUMBER: 73745537
3. **CANCELLATION**– your event will only be cancelled by us in exceptional circumstances beyond our control e.g. in rare cases of staffing or animal health issues. If this should happen you will be offered a full refund of all monies paid or an alternative date. If **you cancel the deposit paid is non refundable**, however, in extreme weather conditions deposits will be refunded or an alternative date agreed. Rain unless heavy does not affect experiences here as we have plenty of shelter ,an indoor party barn and another large building and many indoor activities(.We find that, generally the horses don't mind a little bit of rain and children don't either!)
Cancellations must be made before 9.00 am on the day of the event.
4. **SUPERVISION**–. We will fully supervise children handling the ponies but very young and less confident children may need a known adult with them
5. **FEEDING THE PONIES**– **Please do not feed the ponies** with any sweets, titbits or anything. This can lead to Colic which is a serious condition and can (and has been here) be fatal. **Supervised feeding will be offered as an activity.**
6. **DOGS**_- No dogs or other animals may be brought onto the premises under any circumstances. (Guide dogs excepted of course).
7. **SAFETY** – Safety of the children and the ponies is of paramount importance to us.
A safety briefing will take place before the start of your session and as activities progress
Our ponies are generally quiet, well trained, used to children and frequently handled. However, whilst PPIM will take every precaution to ensure the safety and wellbeing of all visitors whilst on the premises, horses, like all animals can be easily disturbed and as a result could become unpredictable. PPIM cannot accept liability for any injury, damage or loss sustained as the result of such an event. **In addition PPIM accept no responsibility for damage to vehicles or property whilst on site.**
9. **PUBLIC LIABILITY** – We have **FULL public liability insurance** to and this dictates some of our conditions.
10. **CANCELLATION OF A SESSION IN PROGRESS** - We ask that our instructions and guidelines for behaviour when handling our ponies are followed for the safety of the children and the welfare of the ponies. PPIM reserve the right to cancel any session in progress should the behaviour of any child / children become unacceptable and pose risk to any of our animals or to other children. Should this situation occur, no monies paid will be refunded. **To date this has NEVER HAPPENED.**
11. **RIDING**– It is not possible for children to ride any of our ponies (all activities with the ponies are in hand activities) and parents should ensure that all children are aware of this so as to avoid any disappointment. However, there are more than enough really exciting activities to keep children delighted for the whole duration. **This has NEVER been a problem.**
12. **CLOTHING & WHAT TO WEAR**– PPIM advises that smart clothes are avoided due to the nature of some of our activities and the fact that activities are predominantly outdoors. We suggest jeans / playwear and trainers / school shoes or wellies would be ideal. Our well kept party paddock has good grass cover and is not normally muddy, however this cannot be guaranteed. Please be aware that the grass could be wet and children may get dirty. PPIM cannot accept responsibility for damage to clothing or clothing becoming soiled. PLEASE remember a coat is essential. The wearing of wellingtons is encouraged

13. **ADULTS** – Please advise PPIM of the number of adults that will accompany the children on the session
14. **HYGIENE**– children must use the hand wash facilities provided before consuming any snacks or drinks.
15. **NO ACCESS AREAS** – Children (and adults) must only enter the paddocks under the supervision of PPIM and must not, under any circumstances enter any other gated field or stable without asking first, all of which are clearly marked with No Entry signs. Electric horse fencing will normally be turned off for the duration of the session, however, for purposes of best practice all areas not used during your experience will be marked as no entry and these signs must be observed by children and adults. **Please DO NOT allow children to climb gates, fences or hang on/pull the electric fencing tapes.**
16. **PHOTOGRAPHS** – PPIM may photograph ‘TASTER’ activities for use on our website or for advertising purposes. Any parents who do not wish their child to be photographed must advise PPIM in advance. Very occasionally we may video but we will always seek permission from you first.
17. **ARRIVAL & DEPARTURE TIMES** – **PLEASE DO NOT ARRIVE EARLIER THAN THE TIME BOOKED as we are using this time to set up** Please arrive on time for the start of your experience .We ask that you depart our premises within 10 minutes of the taster session finishing, allowing us sufficient turnaround time for the next party/taster session or to allow us time to tidy and clean before putting the horses to bed etc.
